PRIMARY RESPONSIBILITIES	<ul> <li>To lead the Youth Program delivery and advocate for Member Experience</li> <li>Direct, facilitate, chair the Branch Youth Program Team, including promotion of Youth Program as the key element of Scouting in Queensland.</li> <li>Set the "tone" for Youth Program delivery in Queensland and be available as a reference person for the Deputy Chief Commissioner Member Experience and the Chief Commissioner in the selection of Branch Program Commissioners.</li> <li>Oversee the delivery of the Program elements, as part of the overall branch strategy and action planning.</li> </ul>



	<ul> <li>Relate directly to the Assistant Chief Commissioners on Member Experience matters, in consultation with and providing information to the Chief Commissioner.</li> <li>Act for and on behalf of the Chief Commissioner as required.</li> <li>Visit Branch major youth events.</li> <li>Maintain a close working relationship with all Assistant Chief Commissioners and Branch Commissioners to enhance Program development.</li> <li>Keep abreast of community attitudes and concerns and professional areas of interest relevant to our Program.</li> <li>Through the Assistant Chief Commissioner Specialist Activities support the functions of the Branch Commissioner (International) by promoting interstate and international contacts for Scouts and liaise with Branch Commissioner (International) to update selection criteria for adults applying to attend interstate or overseas events.</li> <li>Support Branch Commissioners to prepare and manage budgets annually.</li> <li>Recruit assistance for specific projects, in consultation with the Deputy Chief Commissioner Member Experience and the Chief Commissioner.</li> <li>Undertake other projects or duties from time to time, as a member of the Branch Team, as agreed with Deputy Chief Commissioner.</li> <li>Representing Queensland Branch at the National meetings as requested by the Deputy Chief Commissioner.</li> <li>Attend Chief's Council and BSO Team Leaders meetings monthly and other meetings and conference as requested.</li> <li>Any other duties requested by and in support of the Chief Commissioner</li> <li>Work collaboratively with any BEC subcommittee to achieve strategic or operational outcomes.</li> </ul>
CRITERIA	<ul> <li>Have a sound knowledge and strong commitment to the purpose of Scouting, its policies and procedures and have a clear understanding of the methods which make it distinctive from other youth organisations.</li> <li>Be enthusiastic and able to motivate, build, lead, and chair teams among both youth and adults.</li> <li>Be inclusive in leadership style.</li> <li>Be respectful of all members of their team (and of those in the wider community) recognising individual differences as a resource.</li> <li>Be able to communicate effectively with all levels in Scouting and be an accomplished public speaker to the community.</li> <li>Be able to mediate, carry out reviews, write reports and make recommendations.</li> <li>Have a sound understanding of the use of technology, information systems, communications, and video conferencing to achieve the outcomes of the role.</li> </ul>
