PURPOSE The purpose of the Branch Commissioner (Adventurous

Activities) role is the promotion, development and maintenance of an adventurous activities skills / training framework with supporting documentation, and the provision of advice relating

to, and overall management of, each core and specialist adventurous activity area into the Youth Program.

PRIMARY RESPONSIBILITIES

To advise the Chief Commissioner, Assistant Chief Commissioner (Specialist Activities), Assistant Chief Commissioner (Major Activities), Assistant Chief Commissioner (People & Culture), Assistant Chief Commissioner (Youth Program), Region and Branch Commissioners on contents and methods of incorporating each of the core and specialist adventurous activity areas



- To advise the Assistant Chief Commissioner (Specialist Activities) on policies relating to conducting and supervising adventurous activities undertaken by Queensland Branch members.
- Develop and support programs for the training of members in adventurous activities in consultation with the Branch Commissioner (Adult Training and Development)
- Establish Guide development program.
- To encourage and assist Queensland Branch members in the interpretation of and compliance with adventurous activities policy.
- Develop and maintain policies relating to conducting and supervising adventurous activities based on Scouting and community standards for recommendation to the Chief Commissioner and the Assistant Chief Commissioner (Specialist Activities).
- Ensure sufficient Guides are trained and recommended for appointment and reappointment to provide adventurous activities and training within the Queensland Branch.
- Convene forums and conferences as required to ensure appropriate members are informed of relevant training, policy and legislative changes.
- Assist Queensland Branch members in the interpretation of and compliance with adventurous activities policy.
- To represent the Queensland Branch on the National Adventurous Coordination Committee.
- Attend and represent the Queensland Branch at various outdoor recreation industry meetings, workshops, committees and conferences so that the Branch is kept up to date with industry standards, issues and developments.
- To ensure good relations are maintained with the Queensland Outdoor Recreation Federation, other outdoor industry groups and relevant youth organisations.
- Any other duties requested by and in support of the Assistant Chief Commissioner (Specialist Activities) and Chief Commissioner.

CRITERIA

- A personal commitment to the Aim and Principles of Scouts Australia, and an ability to convey a positive and constructive image of Scouting and reinforce the fundamental importance of the Scout Promise and Law
- Have a sound knowledge and strong commitment to the purpose of Scouting, its policies and procedures and have a clear understanding of the methods which make it distinctive from other youth organisations.



- Be enthusiastic and able to motivate, build, lead, and mentor teams among both youth and adults.
- Be inclusive in leadership style.
- Be respectful of all members of their team (and of those in the wider community) recognising individual differences as a resource.
- Be able to communicate effectively with all levels in Scouting.
- Be able to mediate, carry out reviews, write reports and make recommendations.
- Have a sound understanding of the use of technology, information systems, communications and video conferencing to achieve the outcomes of the role.
- Knowledge and commitment that when participating or leading an activity any safety concerns or risks are identified, raised and appropriate immediate action is taken.
- Have a sound understanding of Child Safety in accordance with Qld. Branch Policies, Principles, Standards and Procedures.
- Proven ability to prioritise workloads and multitask to ensure commitments are completed in a timely manner.

ROLE SPECIFIC CRITERIA

- Hold or be prepared to complete Program Support Leader Proficiency training within twelve months from appointment and the Wood Badge training within three years of appointment.
- Relevant experience in the outdoor recreation and/or adventurous activity field.
- High level writing skills to prepare and comment upon adventurous activity and/or outdoor recreation training and assessment material and to develop policy related to adventurous activities and outdoor recreation.
